11/24	Grand Island Blvd.	Welfare Check	Deputies responded to a 911 hang up call from a payphone at Tops Market. Deputies were unable to locate anyone in need of police assistance.
11/24	Greenway Rd.	Animal Loose	Complainant states she found a dog running loose in the neighborhood. The complainant was able to reunite the dog with its owner.
11/24	Grand Island Blvd.	Suspicious Vehicle	Deputies located an unoccupied suspicious vehicle in the parking lot of Tops Market. No owner was identified.

11/25	Whitehaven Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
11/25	Bush Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
11/26	West River Rd.	Harassment	Complainant states that her neighbor was harassing his family and he has a duly served order of protection against the subject. Deputies arrested 55 y/o Peter Olivieri of Grand Island for Criminal Contempt 1 st Degree (Class E Felony) and Harassment 2 nd Degree (a Violation). Olivieri was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
11/26	Love Rd.	Larceny	Complainant states that sometime during the night, an unknown person(s) stole various items from her unlocked vehicle. Investigation Ongoing.
11/26	Stony Point Rd.	Fraud	Complainant states that an unknown person(s) opened a credit card account in her name and made unlawful purchases.
11/26	Park La.	Identity Theft	Complainant states that an unknown person(s) used an online account to make unlawful purchases.
11/27	Grand Island Blvd.	Larceny	Complainant states that an unknown person(s) stole the license plates from his vehicle.
11/27	Stony Point Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident with injuries. Grand Island Fire Department treated multiple subjects on scene for seemingly non-life threatening injuries.
11/27	Whitehaven Rd.	Deer Struck	Deputies responded to a report of a deer struck on Whitehaven Rd. No injuries were reported.
11/27	Grand Island Blvd.	Suspicious Vehicle	Deputies located a suspicious vehicle parked in the lot of a closed business late at night. No subjects were observed in the area.
11/28	Love Rd.	Burglary	Deputies responded to a report of an alarm ringing at Sunoco. Upon arrival, Deputies found that the front door to the business had been smashed. A check of the surveillance footage showed a male subject smashing the door and making entry to steal various brands of cigarettes. The subject is described as a white male, medium build, dark colored hair and a goatee or moustache. 11/28	Grand Island Blvd.	Suspicious Incident	Deputies located an open door at Brick Oven Pizzeria. The open door appeared to be an oversight, and nothing was reported stolen.
11/28	Whitehaven Rd.	Reckless Operation	Complainant states that numerous dump trucks were speeding down Whitehaven Rd. Deputies checked the area but were unable to locate the vehicles.

11/28	Blackmon Rd.	Robbery	subjects who then beat him with a baseball bat and stole his hat. Erie County Sheriffs Officials were able to recover evidence and identify the 2 suspects Arrests are expected to be made in coming days. More information to follow.
11/29	Stony Point Rd.	Animal Loose	Complainant states that a cat was running in and out of the roadway. Deputies checked the area but were unable to locate the animal.

11/30	Sturbridge La.	Suspicious Incident	Complainant states that she arrived home and found her front door was unlocked and she heard unusual noises coming from inside the residence. Deputies checked the residence but found no one inside. Nothing was reported stolen.
