The Erie County Sheriff's Office responded to 355 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

05/30	Customer Trouble	Long Rd.	Deputies were called by a business reporting loud and argumentative customers. Patrol escorted the customers from the business. No charges.
05/30	Burglary in Progress	Tiller Trail	Deputies responded to a report of two or three subjects attempting to break-in to a home. Subjects fled the scene prior to patrol arrival. Search of the area was negative. The complainant/occupant of the home gave descriptions to detectives. Investigation ongoing.
05/31	DWI/Alcohol	Stonypoint Rd.	Deputies responded to a one vehicle accident versus a tree. The driver showed signs of impairment by alcohol and/or drugs. The driver was transported for medical treatment. Deputies followed and interviewed the driver and requested a blood test to determine the drivers blood alcohol content. The driver refused. The driver was charged with DWI and released on traffic tickets.
06/01	Fire-Other	Grand Island Blvd.	Deputies received a call for a possible structure fire at a business. When patrol arrived, the building was fully involved. Building was cleared and fire was extinguished. Erie County Sheriff's Office Fire Investigators are conducting an investigation into the cause of the fire.
06/01	Fire-Residential	West River Rd.	Deputies received a call for a structure fire. All occupants cleared the structure without injury. Erie County Sheriff's Office Fire Investigators are conducting an investigation into the cause of the fire.
06/02	DWI/Alcohol	Creekside Dr.	Deputies initiated a traffic stop after observing traffic violation(s). Upon interview Deputies noted signs of intoxication from the driver. Standardized Fiueld Sobriety tests were conducted, and the driver was arrested for DWI. The driver's breath test results returned a .17 BAC, more than twice the legal limit. Driver was processed and released on traffic tickets to a sober third party. Vehicle placed under a twelve- hour hold.

06/05	Traffic Stop/ Warrant Arrest	I-190 @ Whitehaven Rd.	Deputies initiated a traffic stop on vehicle after observing traffic infraction(s). Further investigation showed that a passenger had an active warrant out of Amherst. The subject was taken into custody and turned over to Amherst PD.
