



# Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 184 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
7/6	Whitehaven Rd.	Fire	Deputies assisted Grand Island Fire Department for a report of a dumpster fire at the Byblos Niagara Resort and Spa Hotel.
7/6	Carol La.	Suspicious Incident	The complainant states that a suspicious vehicle was driving down the street and the driver appeared to be getting out and checking for unlocked vehicles in numerous driveways. Deputies located the vehicle and the driver who was conducting his paper delivery in the neighborhood. Nothing was reported damaged or stolen.
7/6	Whitehaven Rd.	Larceny	The manager of Noco states that a large sum of money was missing from the register and was seemingly taken by a known employee. Investigation Ongoing.
7/6	East Park Rd.	Loud Music	The complainant states that loud vulgar music was coming from a nearby residence during the evening hours. Deputies checked the area and determined the complaint to be unfounded.
7/6	South La.	Fireworks Use	The complainant states that someone in the area was using fireworks and the debris almost struck his dog. Deputies located the subject and advised her.
7/6	Wallace Dr.	Fireworks Use	The complainant stated that fireworks were being used somewhere in the area. Deputies checked and determined the complaint to be unfounded.
7/6	Pellamwood Ct.	Loud Music	The complainant states that loud music was coming from a nearby residence. Deputies located the residence and advised the occupants.
7/6	West River Rd.	Fireworks Use	The complainant stated that someone was using fireworks in the area of her residence. Deputies checked and determined the complaint to be unfounded.
7/6	Whitehaven Rd.	Suspicious Person with Vehicle	The complainant states that a group of people were standing around a vehicle in the street during the late hours of the night. Deputies located the subjects whose vehicle had become disabled and were making arrangements to move it.
7/7	Ferry Rd.	Road Obstruction	The complainant states that a deceased deer was lying in the roadway. Deputies removed the deer and notified

			NITTEC for removal of the carcass.
7/7	Trails End St.	Suspicious Incident	The complainant states that a dark colored pickup truck was speeding up and down the street during the late hours of the night. Deputies checked the area but were unable to locate the vehicle.
7/7	Ransom Rd.	Youth Activity	The complainant states that a youth subject was whipping a lacrosse ball against the wall of the High School. Deputies checked the area but were unable to locate the youth.
7/7	Sandy Beach Rd.	Animal Complaint	The complainant stated that her cat was attacked by a dog belonging to her neighbor. The Dog Control Officer was notified.
7/7	Love Rd.	Suspicious Incident	The complainant states that several kids were selling drugs in the area and when he yelled at them to leave they followed him to Sunoco. The youths then got into a vehicle and drove off. Deputies checked the area but were unable to locate the vehicle.
7/8	Fieldstone Dr.	Suspicious Incident	The complainant states that an unknown person in an apartment complex nearby was hitting golf balls toward the complainant's residence. Deputies checked the area but were unable to locate the subject. No damage was observed.
7/8	Grand Island Blvd.	Accident Hit & Run	Deputies responded to a report of a 2 car motor vehicle accident and the complainant stated that 1 vehicle fled the scene. Deputies checked the area but were unable to locate the vehicle that fled. No injuries were reported.
7/9	Hazelwood La.	Larceny	The complainant states that an unknown person(s) stole a valuable watch during a 4 <sup>th</sup> of July party at his residence. Investigation Ongoing.
7/9	I-190	Traffic Arrest	Following a traffic stop, Deputies arrested 45 y/o Lisa Rhodes of Niagara Falls after a DMV check showed her license was currently suspended. Rhodes was charged with Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree (Misdemeanor) and was issued an appearance ticket returnable to the Town of Grand Island Court.
7/9	Love Rd.	ATV Operation	The complainant states that a known subject drove an ATV on his lawn causing minor damage. Deputies located the subject and advised him. The complainant did not wish to pursue charges.
7/9	East Park Rd.	Suspicious Incident	The complainant states that she heard a loud noise outside of her residence and was concerned. Deputies checked the area but were unable to locate any subjects. No damage was observed.
7/10	Fix Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident involving power lines being struck. National Grid was notified and no injuries were reported.
7/10	Love Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
7/10	Grand Island Blvd.	Criminal Mischief	An employee of Tim Hortons states that a known person wrote a vulgar word on her vehicle with an unknown substance. Deputies spoke to the subject and advised him. The complainant did not wish to pursue any charges.

7/10	East River Rd.	Suspicious Person	The complainant states that a person was going door to door in the area and doing surveys. The complainant was worried it was a scam. Deputies located the subject who had the proper paperwork to solicit on Grand Island.
7/11	Carter Dr.	Youth Activity	The complainant states that during the night, unknown youths were throwing eggs at houses and ringing doorbells. No damage was reported.
7/11	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
7/11	East River Rd.	Suspicious Incident	The complainant states that 2 subjects were climbing on the South Grand Island Bridge. Deputies checked the area but were unable to locate the subjects.
7/12	Beaver La.	Drunk Driving	The complainant states that a female subject was sleeping in a vehicle. Deputy's investigation led to the arrest of 51 y/o Valeria Mosley of Buffalo for Driving While Intoxicated. Mosley refused to submit a sample of her breath for chemical analysis. Mosley was transported to the Erie County Holding Center pending arraignment in the Town of Grand Island Court.
7/12	West River Rd.	Suspicious Incident	The complainant states an elderly male subject was stopped in his vehicle in the middle of the road. Deputies checked the area and determined the complaint to be unfounded.
7/12	Oakridge Dr.	Suspicious Incident	The complainant states that 2 juveniles were going in and out of backyards in the neighborhood. Deputies spoke to the youths who were fishing in a local pond.
7/12	Grand Island Blvd.	Larceny	The complainant states that he dropped his wallet while filling his gas tank at a local gas station. When he returned, he found his wallet but several items were missing. Investigation Ongoing.
7/12	Carter Dr.	Suspicious Incident	The complainant states that she found a gas can sitting near the curb and no one was around it. Deputies turned the gas can over to the Grand Island Highway Department for disposal.
7/12	Fix Rd.	Loud Music	The complainant states that a band was playing loud music somewhere in the neighborhood. Deputies located the residence and advised the occupants.
7/12	Forest Creek La.	Loud Music	The complainant states that loud music was coming from a party nearby in the neighborhood. Deputies advised the occupants of the residence.
7/12	Schwegler Rd.	Suspicious Incident	The complainant states that he heard a loud boom come from a residence nearby. Deputies checked the area and found that a firework had been set off but did not observe any subjects.
