The Erie County Sheriff's Office responded to 363 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

07/12	Accident – Hit and Run	South State Pkwy	Deputies responded to a car versus motorcycle accident. The car fled the scene prior to patrol's arrival. Motorcycle operator reported no injury. Accident report completed and investigation ongoing.
07/14	Suspicious Person	Old Carriage House Rd.	Deputies received a complaint that after being alerted by their homes security camera system a homeowner witnessed three unknown people looking into the home. Patrol checked the area but was unable to locate the group. Police report completed and increased premise checks conducted.
07/14	First Aid	Niagara River	EC Marine Unit and Deputies received a call reporting a person that appeared to suffer a medical emergency while riding a jet ski. The subject was facedown in the water and not breathing. Subject was brought to shore and CPR was performed. The subject was transported by ambulance for medical treatment.
07/14	DWI/Alcohol	Route 33 @ Best St.	Deputies initiated a traffic stop for an observed traffic violation. During interview Deputies noticed the driver exhibited signs of intoxication. New York Standardized Field Sobriety Tests were performed, and the subject was arrested for DWI. The driver refused to take a breath test. Driver processed and released to a sober third party and the vehicle was placed under a twelve-hour hold.
07/15	Animal Bite	East Park Rd.	Deputies received a report from a complainant that was bitten by a dog. Deputies conducted initial interview and referee tot eh Dog Control Officer.
07/15	Customer Trouble	Lovre Rd.	Deputies were called by an employee of a store reporting an unruly customer. Subjects left prior to patrols' arrival. Deputies located the subject who explained that they were upset over a chicken wing they purchased that was too hard. All parties advised.
07/16	First Aid – Drug Related	Orchard Rd.	Deputies received a report of a first aid, possibly drug related. Narcan administered and the subject was transported by ambulance for medical attention.
07/17	Suspicious Incident	Ferry Rd.	Deputies received a call from a complainant reporting that someone accessed their breezeway overnight. The unknown

			person left a pack of cigarettes and moved their hot tub cover. Deputies investigating.
