The Erie County Sheriff's Office responded to 205 calls the week of this report. Below is a sampling of the noteworthy incidents on Grand Island.

8/2	Settlers Row	Suspicious Incident	The complainant states that an unknown person(s) pushed on his front door and rang the doorbell before fleeing during the late hours of the night. Deputies checked the area but were unable to locate any persons.
8/2	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of a local business. No injuries were reported.
8/2	Grand Island Blvd.	Customer Trouble	An employee of Chateau Motor Lodge states that a customer was refusing to leave his room after check out. Deputies advised the subject who left without further incident.

8/2	Stony Point Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole various items from his unlocked vehicle.

8/4	Huth Rd.	Open Burn	Deputies located a large fire burning in the yard of a residence on Huth Rd. Deputies advised the occupant who put the fire out with a garden hose.
8/4	Whitehaven Rd.	Suspicious Incident	The complainant states he heard the burglar alarm

			activate in his garage while he was inside his residence. Deputies checked the garage and determined the alarm to be unfounded.
8/4	Ward Park Rd.	Barking Dog	The complainant states that a dog was barking for several hours during the late hours of the night. Deputies checked the area and determined the complaint to be unfounded.
8/5	Beaver La.	Suspicious Incident	The complainant states that she observed a male subject with a flashlight inside of her neighbor's car during the late hours of the night. The subject left on foot prior to the arrival of Patrol. Deputies checked the area but were unable to locate any subjects. Nothing was reported stolen.

8/7	East River Rd.	Larceny	The complainant states that an employee stole various cleaning supplies and stopped showing up for work. Investigation Ongoing.
8/7	Bedell Rd.	Suspicious Person	The complainant states that 2 subjects approached her in Veterans Park and were waving their hands during the late evening hours as she was leaving in her vehicle. Deputies located the subjects in the park and determined their vehicle had broken down. The subjects were assisted by patrol.
8/8	Grand Island Blvd.	Welfare Check	Deputies responded to a report of a 911 hang up call at Tops Markets. Deputies checked the premise and were unable to locate any person in need of police assistance.
8/8	Stony Point Rd.	Animal Loose	The complainant states that her dog got loose in the past few hours. The Dog Control Officer was notified.
8/8	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot the Niagara Falls Welcome Center. No injuries were reported.
8/8	Blackmon Rd.	Pistol Permit Investigation	Deputies conducted a background check of a person who applied for a pistol permit.
8/8	Grand Island Blvd.	Loud Music	The complainant states that loud music was coming from Brick Over Pizza during the late hours of the night. Deputies spoke with employees on location who turned the music off.
